ABOUT DIGITAL INFRASTRUCTURE IRELAND

Digital Infrastructure Ireland (DII) is the collective voice of Ireland's digital infrastructure ecosystem. We represent a community of more than 80 partners spanning every stage of the digital infrastructure lifecycle — from design and construction through to operation, maintenance, and innovation.

DII's purpose is to represent, support, and champion our partners, driving growth and ensuring that Ireland's digital infrastructure remains globally competitive. Through advocacy, policy influence, education, research, and community building, we advance the sector's role in powering Ireland's economy, society, and sustainability agenda.

Key Facts:

- ICT and related services contribute €228 billion annually to Ireland's economy.
- Sector accounts for ~57% of service exports and 42% of all Irish exports.
- 11,445 people employed directly in Ireland by DII partner companies, and ~1.15m globally.
- 80+ partner companies with presence in 38 global cities.

Digital Infrastructure Ireland's 2026–2028 strategy, "Partnerships for Progress", sets out five clear priorities:

- Support aligned policy and legislation to enable continued investment in cloud, AI, and digital transformation.
- Develop a sustainable and resilient national digital infrastructure roadmap.

2. Securing Cost Competitiveness & Ease of Doing Business

- Advocate for a competitive and predictable regulatory, energy, and tax environment.
- Support initiatives addressing energy grid constraints with practical, futurefocused solutions.

3. Enhancing Industry Talent & Skills

- Expand leadership and skills programmes, including Emerging Leaders.
- Partner with training providers and funders to deliver subsidised and market-based training.

4. Building International Linkages

- Promote Ireland as a global centre for digital expertise and exports.
- Engage with EU and global policy forums such as EUDCA and the Climate
 Neutral Data Centre Pact.

5. Driving Sustainability & Social Impact

- Expand environmental initiatives like DCs for Bees.
- o Champion industry-wide sustainability standards and practices.





THE OPPORTUNITY

Ireland is at a pivotal point in its digital journey. Global investment in AI-ready infrastructure is accelerating, but Ireland faces policy, power, and competitiveness challenges that threaten its status as a preferred destination for data centre investment.

At the same time, Ireland has built a globally respected ecosystem of expertise, from engineering consultancy to software design and hardware manufacturing, which is already influencing landmark projects worldwide.

The CEO of DII will be at the forefront of addressing these challenges and opportunities, ensuring Ireland remains competitive, sustainable, and internationally recognised as a hub for digital infrastructure excellence. The CEO will continue to position 'the Irish' at the front and centre in the rapidly growing global digital infrastructure sector.

DII is 11 years old and recently converted from a Limited Company to a Company Limited by Guarantee (not for profit). This change also saw a rebrand from Host in Ireland to Digital Infrastructure Ireland to be more representative of the member base and purpose of DII. The same transition has also seen the adoption of more partner led initiatives and workgroups such as policy and talent. Finally this change has seen the development of a Board of Directors to whom this role will report directly to. This new format allows for greater opportunity to grow the business in line with the industry both in Ireland and globally.

You will have the opportunity to work with many of the world's leading digital infrastructure companies to help influence policy, expand our membership and support the Digital Infrastructure Ireland ecosystem both in Ireland, across Europe and further afield.

You will have the opportunity to develop new self-sustaining revenue streams to better serve the industry, including developing an industry events arm and the potential to develop talent and training arm of the business.

You will have opportunities to develop the organisation in line with industry and partner needs.

This role will be fast-paced and impactful, and it needs someone who brings that energy. If you don't have a background in policy advocacy, this is okay, as you will bring fresh energy and a new perspective. This could be very exciting for us.
